Vice Chairman Operations - Barry Fasbender – FINA Requirements for Swimwear Approval have been published. There is a list of new requirements that are valid until December 31, 2009. Swimsuits must be submitted for approval by March 31, 2009 even if previously approved. There is also a list of requirements that will be in force starting January 1, 2010. For 2110, swimsuits must be submitted for approval by November 1, 2009. Thereafter, the submission deadline will be August 1 of every year. Submission must be made 12 months in advance of FINA World Championship and Olympic Games and must be on the market at least 6 months prior to these events.

Club Assistant will be providing on-line Meet Entry Service for this meet and it should be available later this week. Chabot Swimming expressed an interest in running Hy-Tek Meet Manager themselves. The online entry will include a photo release to which each swimmer must agree.

Barry proposed we accept a new policy for Championships (SC, LC, and SCM) online meet entries. Any competitor, who is part of the meet committee with access to the entrants and the events they've entered, must enter the meet no later than 10 days before the entries for that meet close.

bylaws comport with the requirements and recommendations set forth by USMS begin thinking about any possible amendments PMS may wish to consider at this year's annual convention in September. Changes in the by-laws must be reported to the State of California when approved at the Annual Meeting.
