Executive Committee

Chair—John King, report*

Ransom Arthur Award nominations. This month we nominate a candidate for the Ransom Arthur award that will be endorsed by Pacific Masters. The deadline is March 15 to submit to USMS, there is a two page nomination form to be completed and submitted.

<u>Coach of the Year.</u> This is a call for nominations for Coach of the Year. Presentation of the Coach of the Year will be made at the Pacific Masters Short Course Yards meet in April.

<u>Pacific Masters Championship Point Scoring.</u> We have had a full year of Championship meets at the higher point assignment for places. We agreed to review the impact on our Championship meets after a full year. We have re-scored a couple of the meets to show the results in scoring. Will vote to continue the point model or go back to the scoring recommended by USMS.

<u>Strategic Planning Action Items.</u> At the USMS Convention late last year a group of the delegates met to lay out action items to help grow involvement in our growing organization as well as utilize, help, and involve our over 150 clubs. The initiatives were defined and will be organized into actionable items by next meeting, and will appear on our agenda with progress each month through the coming year.

<u>Registration</u>: 7,884 members; 145 clubs; 373 self-identified coaches have registered for Pacific Masters as of 1/13. Of the 7,884 renewals and new members, approximately 1/3 requested a registration card mailed to their home equating to approximately 2,628 registration cards mailed since November 1st. In 2016 we had 7,781 members; 143 clubs; 327 coaches at this time in January.

Thirty 85+ registrations have been processed and given a refund of \$41 from Pacific Masters. Sixty-six 80-84 registrations have been registered through USMS and had the PacMaster fee waived. Two hundred and seventy-eight 18-24 registrations have been registered through USMS and had the PacMaster fee waived.

<u>Top Ten</u>: Top Ten for SCM was submitted and has been processed by USMS. With a couple of minor corrections they will be approved by the time of this meeting.

Open Water Committee—Phyllis Quinn, report

An email was sent to all the 2016 Open Water Race Directors. This email included information on the new rule changes for 2017, the new required training for the Safety Directors that is currently available on line and the one event registration forms.

Spring Lake, Lake Berryessa, Del Valle and Donner Lake have submitted requests and are currently on the Pacific Master Schedule page.

I would like to ask the committee to discuss and possibly vote on a clear policy on what events are placed on the Pacific Master Schedule page. I receive several requests a year via the USMS Event or Calendar request that ask that an event be recognized by Pacific Masters. (I have one event pending already this year) It has been my position (and that of the committee in the past) that the Pacific Masters calendar is for **Sanctioned** events only, so I have denied these requests. There was some discussion last year that may be this unofficial policy should be made official or be reconsidered.

I have two reasons that I believe that this should become an official policy. The first is that the Sanctioned events have to meet several standards and reviews and we should promote **only** those events that have a good safety record.

The second reason is that the Pacific Masters "stamp of approval" should mean something. Some of the events I have turned down, do not meet our standards, claim to be "for a charity" with no oversight, may not require USMS membership to participate, or may conflict with current Sanctioned

events. (Maybe a straw poll could be taken to give me an idea of what the committee majority wants to do.)

I have one final conflict that will prevent me from attending this meeting. But I will be calling in or attend the rest of this year. I may try to call in during the latter part of the meeting.
